Term	Definition
Fiscal year end date *	If this financial report does not represent a full year, indicate the number of months being reported to the right.

#### **Room Statistics**

Term	Definition
Number of Rooms/ Suites	The total number of rooms at the hotel.
Rooms Available	The total number of rooms available to guests in the hotel multiplied by 365.
Occupancy Percent	Over the year, the percentage of the available rooms that were actually occupied by guests of the hotel.
Average Daily Rate	In dollars, the average amount that a typical room would cost per night at the hotel.

Information and Telecommunications Systems	I/T expenses including computer, internet and telephone systems.
Sales and Marketing	Expenses related to advertising, promotion, and sales activities.
Franchise/ Royalty Fees	If applicable, the amount paid to a hotel company to participate in its marketing system.
Property Operations and Maintenance	Repairs and maintenance necessary for the upkeep of the facility. Does not include capital expenditures.
Utilities	All utilities associated with the operation of the facilities including hydro, propane, gas, heating oil, water and sewage, cable and satellite.
Management Fees	Fees paid to a third-party management individual/company. This category does not refer to management salaries.

Term	Definition
Other Commercial Leases	Revenue from leases signed with tenant(s) but not controlled/managed by the hotel (e.g. retail store, 3rd party restaurant, office).
Third Party Signs (Billboards)	The amount of income received by the property owner from third party sign operator(s) for billboard(s) located on the property.
