Term	Definition
Property Taxes *	The total amount paid in municipal taxes for the most recent fiscal year.
Insurance *	The total amount paid for all types of insurance related to the property operations. Excluded is insurance related to employee benefits which is accounted for under wages and benefits.

Administration Expenses

Term	Definition
Management	Dues and subscriptions, all telecommunication costs, automotive cost for travel/education/training, office supplies, computer supplies, donations, bank and credit card charges.
Legal & Audit Fees	All charges related to legal and accountants/auditors including travel and disbursements.
Professional Fees	All charges related to external consultants including travel and disbursements.
Leasing Commissions	Fees paid to an agent for leasing tenant space.
Marketing &	All charges for promotional advertising, including
Promotion	internet, print, radio, and television advertising.
Office Supplies/	All charges related to office supplies/equipment.

Rental Income Loss

Term	Definition
Vacancy	The total amount of income lost due to vacancies and tenant turnover from the most recent fiscal year.
Collection	The total amount of income lost due to nonpayment of rent by all tenants from the most recent fiscal year.

Capital Cost Summary

Term	Definition
Capital Cost	Costs associated with replacing components of the structure that will require replacing before the end of the structures economic life, such as roof and window replacements. This should not be confused with costs for maintenance.
